Special Benefit for Supporting Families with Children

Eligible Recipients

<For single-parent household>

Those falling under any of (1)-(3) below:

- 1. Those who received a child-rearing allowance in April 2021
- 2. Those who did not receive a child-rearing allowance in April 2021 due to receiving a public pension, etc.
- 3. Those whose income is at the same level as those receiving a child-rearing allowance, such as from sudden changes in household finances due to COVID-19.

<For non-single-parent household>

Those to whom both (1) and (2) apply

- 1. Fathers and mothers and the like with children who were under age 18, as of March 31, 2021, (under age 20 if they have special needs) *Newborns born through the end of February 2022 will also be covered.
- 2. Those who are exempt from the Resident's Tax (per capita) for FY 2021, or those whose incomes changed suddenly on or after January 1, 2021, and became equivalent to levels exempt from Resident's Tax.

Payment Amount: 50,000 yen per child (One time only)

Application Procedure:

- · No need to fill up the form for those who receiving a child allowance and special allowance as of April 2021 and who exempted for resident tax.
- Need to fill up the application form for those who are not receiving any allowance above and the income was decreased .
