<b>Long Term Care Insurance</b> ( <i>Kaigo Hoken-ryou</i> )	4th Installment

\*Deadline of tax payment is Thursday, November 30th. (Same date with direct debit)

\*Direct debit is convenient for tax payment. If you want to switch to direct debit, please take the necessary procedures at least one month before the deadline.
