Deadline of Tax Payment (Feb)

Property Tax (<i>Koteishisan-zei</i>)	4th installment
National Health Insurance (<i>Kokumin Kenkou Hoken-zei</i>)	8th installment
Medical Insurance for the Elderly (<i>Kouki Koureisha Iryou Hoken-ryou</i>)	8th installment
Long Term Care Insurance (<i>Kaigo Hoken-ryou</i>)	6th installment

*Deadline is Thursday, Feb 29th. (Same date with direct debit)

*Direct debit is convenient for tax payment. If you want to switch to direct debit, please take the necessary procedures at least one month before the deadline.

<Consultation counter for tax payment in FEBRUARY (SUNDAY)>

Consultation counter is open on last Sunday of every month for those who are unable to come to the city hall on weekdays and wants to consult regarding the tax payment.

Temporary Special Cash Benefit for Supporting Daily Living

In order to support daily living of people with price soaring issues, a special benefit will be provided for eligible households.

*Application form will be sent to eligible households from early February.

*Please submit your application form.

Amounts: 70,000yen

Others: Some households need to apply. For details of qualification, please visit the city hall counter.

Special Benefit for Supporting Families with Children

Eligible Recipients: If you meet the following conditions and not yet have applied, please make an application for the benefit.

<For non-single-parent household>

Those who are raising a child born between April 2nd, 2005 (17th year of Heisei) and February 29th, 2024(6th year of Reiwa), and also meet any of the following conditions. (Those who are recognized as a recipient of Special Child-rearing Allowance, the corresponding period of date of birth of a child starts from April 2nd, 2003, 15th year of Heisei.)

- Exempted from the Resident's Tax (per capita) for 2023 (5th year of Reiwa).
- Not exempted from the Resident's Tax (per capita) for 2023 (5th year of Reiwa) but experienced sudden dropped income due to the rising food prices and other items, and became equivalent to levels of exemption from Resident's Tax.

<For single-parent household>

- Those who did not receive a Child-rearing Allowance for March 2023 due to receiving a public pension.
- Those whose income has been affected by higher prices for food and other items and whose income became equivalent to that of child support recipients.

Amount: 50,000 yen per eligible child (paid only once)

Notes: You don't have to make application if...

- you have received the same benefit of 2022 (4th year of Reiwa) as non-single-parent household.
- you have already received Child-rearing Allowance for March 2023 (5th year of Reiwa).
