Use direct debit to make your payment easier. There is no need to go over to banks, and you don't have to worry about forgetting payments!

Please make an application for direct debit at a financial institution bringing your bank pass book, registered seal (todokedein), tax payment notice, etc. (Necessary documents may vary by financial institution.)

*Please complete the procedure at the bank counter one month before the payment date.

Abolition of Demand Fees and Account Failure Notices for municipal and other taxes

Due to the partial revision of the Yuki City Tax Ordinance, the demand fee for the following tax items and the account transfer failure notice will be abolished from April 2024.

In case of payment failure (your balance is insufficient), please inquire of an appropriate division about the matter or make payment of taxes using a demand letter.

Items to be abolished and inquiries:

- Property tax (*koteishisan-zei*), City Planning Tax (*toshi keikaku-zei*), Municipal & Prefectural Tax (*shikenmin-zei*), Light motor vehicle tax (*keijidousha-zei*).
