In order to support daily living of people with price soaring issues, a special benefit will be provided for eligible households.

Amounts:100,000yen/per household

50,000yen/per child

**Eligible person:** Those who meet both of the following requirements.

- Who have completed resident registration as a householder as of December 1st of Reiwa 5th year (2023).
- · Who is subject to *kintouwari* only, regarding resident tax.

## **Tax Payment for Vehicle Tax (Deadline is May 31st)**

Vehicle tax is levied on owners or users as of April 1st every year.

Please make payment by the deadline when you receive a tax bill.

You can also make a payment at Financial institution, Post office, Convenience stores or F-REGI website using the Credit Card.

If you have a physical or mental disability and meet certain requirements, there is a system to exempt the vehicle tax by filling the application form. (Available until Fri, May 31st to apply.)
