Temporary Special Cash Benefit for Supporting Daily Living

In order to support daily living of people with price soaring issues, a special benefit will be provided for eligible households.

*Application form was sent to eligible households in late March.

*Please submit your application form.

Amounts:100,000yen/per household

50,000yen/per child

Eligible person: Those who meet both of the following requirements.

- Who have completed resident registration as a householder as of December 1st of Reiwa 5th year (2023) .

- Who is subject to *kintouwar*i only, regarding resident tax.

Others: For details of qualification, please visit the city hall counter or call support center

Application Deadline: Friday, May 31st, 2024

*If you send it by mail, make sure it arrives no later than the date mentioned above.

Tax Payment for Vehicle Tax (Deadline is May 31st)

Vehicle tax is levied on owners or users as of April 1st every year.

Please make payment by the deadline when you receive a tax bill.

You can also make a payment at Financial institution, Post office, Convenience stores or F-REGI website using the Credit Card.

If you have a physical or mental disability and meet certain requirements, there is a system to exempt the vehicle tax by filling the application form. (Available until Fri, May 31st to apply.)
