Renewal of Labor Insurance

<About annual renewal>

The terms of renewal of Labor insurance (Worker's compensation insurance / Employment insurance) is Mon. Jun 3rd to Wed. July 10th for 2024 (*Reiwa 6 nendo*).

You can make declaration and payment at the closest labor bureau (*Rodokyoku*) or Labor Standards Inspection Office (*Rodokijunkantokusho*). Also you can pay at financial institutions.

<About electronic application system>

Use electronic application system for applying labor insurance. You can complete it by using "e-Gov". You need to get gBizID for using "e-Gov" system.

Available time: 6:30 to 23:00 (Excluding maintenance day, Year End and New Year)

Fee: 200 yen per certificate
