\*Deadline is Mon. July 1st. (Same date with direct debit)

\*Direct debit is convenient for tax payment. If you want to switch to direct debit, please take the necessary procedures at least one month before the deadline.

Consultation counter is open on last Sunday of every month for those who are unable to come to the city hall on weekdays and want to consult regarding the tax payment.

## Tax Payment of Vehicle Tax (Category base)

Deadline of 6th Year of Reiwa vehicle tax (category base) is May 31st (Friday).

If your payment get delay, you will be paying the tax with delinquent charge.

And also, if you leave the unpaid tax, we will investigate your assets (Real estate, vehicles, salaries, and savings.) and disposition may be executed.

## About procedure for National Health Insurance (Kokumin Kenkou Hoken)

To Join / quit The National Health Insurance is not proceeded automatically. Please come to the City Hall to complete a procedure within 14 days when you are in one of the following conditions. Please do not use the card that has already expired. If you use the expired card, you will have to return the medical expenses of the National Health Insurance.

### When you Join the National Health Insurance.

- When you are no longer insured by any other type of health insurance.
- When you move in from outside the city
- When a child is born
- When you no longer receive welfare assistance

### When you quit the National Health Insurance.

- When you apply for other type of health insurance.
- When you move out to another city.
- When the insured passed away.
- When you become eligible for the medical care system for the elderly

Due to construction work within the railroad crossing, the following area are completely closed to traffic.

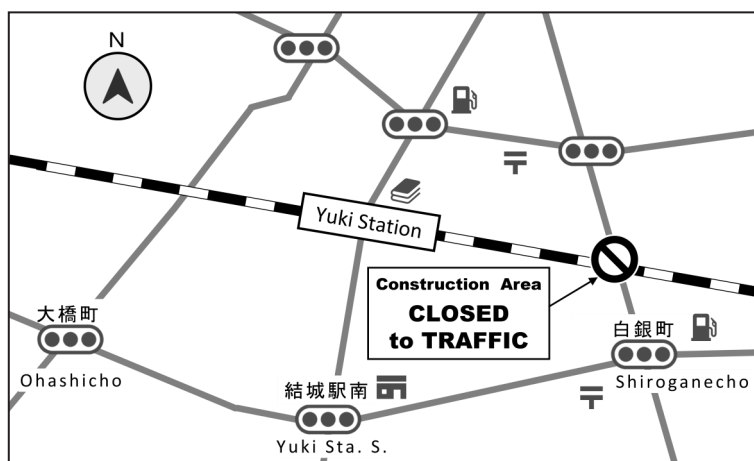
