Starting date: October 1st, 2024.

About the system: Medical expenses will be returned to you. The amount you paid to hospitals/clinics will be returned to you later on by bank transfer.

*Please register your bank account details in advance for the transfer action.

Eligible persons:

- Pregnant or nursing mothers (applicable cases are limited to treatments for continuation of pregnancy and safe delivery.)
- Child (applicable ages are from 0 to 18. *Until March of the year he/she turned 18.)

How to apply:

- Basically, there is no need to make application if you had medical examinations inside Ibaraki prefecture.
- *If any of the following applies, please make application at the city hall counter.
- You had medical examinations outside Ibaraki prefecture.
- You had medical examinations inside Ibaraki prefecture and paid less than 600 yen.

Vaccination has Began (both Influenza and COVID-19)

<INFLUENZA VACCINATION>

Taking the vaccine before the flu season will be effective.

Period: from Tuesday, October 1st, 2024 to Friday, January 31st, 2025.

*No subsidy for those who got vaccinated out of vaccination period.

Eligible persons: For those who wants to get the vaccination and meets either No.1 or No.2 below.

No.1. 65 years old and above or those who are between 60 and 64 years old and have internal disabilities equivalent to level 1.

No.2. between 6 months old and 18 years old. (Until the equivalent age of 3rd year senior high.)

Subsidy Amount: ¥2,000 per person. (Only once.) *Extra cost will be your own expense.

<COVID-19 VACCINATION>

COVID-19 vaccination has been designated as a routine vaccination from Reiwa 6th year (2024).

Period: from Tuesday, October 1st, 2024 to Monday, March 31st, 2025.

*No subsidy for those who got vaccinated out of vaccination period.

Eligible persons: For those who wants to get the vaccination and meets either No.1 or No.2 below.

No.1. 65 years old and above.

No.2. between 60 and 64 years old and have internal disabilities equivalent to level 1.

Subsidy Amount: ¥10,300 per person. (Only once.) *Extra cost will be your own expense.

COMMON INSTRUCTION for both vaccinations:

What to bring:

- Vaccination fee
- Health insurance card (hokensho)
- Maternal and Child Health Handbook (boshitecho) (only for children for their influenza vaccination.)
- Recipient Certificate of Livelihood Protection (Seikatsuhogo-jukyuushashou), if you have one.
- Physical Disability Certificate (between 60 and 64 years old and have internal disabilities equivalent to level 1), if you have one.

How to make reservation: contact a medical institution directly.

- A list of the medical institutions are posted in the city website.
- A simultaneous vaccination is available in some of the institutions.

Raising Income Limit for Child Rearing Allowance

Child Rearing Allowance Act will be partially revised as of November 1st, 2024.

There will be a raise in both amounts as follows: Income Limit and Third Child Addition.

<Income Limit will be raised>

There will be a raise in the Income Limit which stands for a deciding factor of Full Subsidy or Partial Subsidy.

The change is as follows:

<Third Child Addition will be raised >

The amount of the payment for the third child and above -Third Child Addition— will be raised. The amount will be equivalent to that of the Second Child Addition.

Amount change for Full Subsidy

Before: $6,450 \text{ yen} \rightarrow \text{After: } 10,750 \text{ yen}$

Amount change for Partial Subsidy

Before: between 6,440 yen and 3,230 yen → After: between 10,740 yen and 5,380 yen
