Year-end Traffic Accident Prevention Campaign of Ibaraki

Safety Reflector is Essential safety tool in Dark Roads!! Campaign period: Sun. Dec. 1st to Sun. 15th.

Priority subject: 1) Protect Children and elderly persons (especially when crossing roads).2) Prevent traffic accidents during evening and night time. 3) Eliminate drunk driving.

Road Traffic Act has been revised!! You will be punished by law (up to 3 years in prison or a fine of up to 500,000 yens) if you ride a bicycle and use smartphone at the same time or have a behavior of drunk riding. Please note that aiding and abetting is also a crime and will be punished by law.

Issuance of Tax Payment Certificate (Nouzei Shoumeisho) at Prefectural Taxation Office (Kenzei Jimusho)

Mainly, there are two types of certificates you can apply in Prefectural Taxation Office *(kenzei jimusho).* **Type of certificate:** 1) Proof of Tax Amount 2) Proof of No Outstanding Payment

Items to bring: • Zairyu card • certificate fee(400 yen per certificate) • receipt of the tax payment made in last two weeks.

*If someone other than the applicant is applying, a letter of attorney is required.

Between home and destination, available for fixed price regardless of distance.

Operating date and time: Monday to Friday, 9 am to 3 pm

(Excluding National holidays, year-end and New Year holiday season) * Reservation Required

Usage section: between home and destination (limited to medical institutions, public facilities, commercial facilities, financial institutions and stations inside Yuki city.) *not allowed to use from one place to another.

Eligible person: resident of Yuki city of age 65 and over
