Tax Office & Municipal Office Joint Orientation will be held for final tax return procedure by smartphone. You can file final tax return on site (for 2024 only).

**Date and Time:** Thursday, January 30th. [1st session: from 9:00 am] [2nd session: from 1:30 pm] **Venue:** City Hall 1st Floor, Multipurpose Space.

Eligible persons: those who will file income tax return for the year 2024 (Reiwa 6th year).

\*Except tax return subject to income from land/building transfers and Quasi-Final Return.

Capacity: first 50 applicants are only accepted in each session.

#### Things to bring:

- Smartphone (limited to compatible models for My Number Card reader)
- My Number Card
- Passwords of *My Number Card* 1) four-digit number 2) alphanumeric digits of 6 to 16
- Required documents for Final Tax Return.

How to apply: make application at City Hall counter or by phone.

Application period: from Wednesday, January 15th to Friday, 24th.
