For those who are Eligible for a Third Child Addition system

Regarding Child Allowance on and after April 2025, a procedure is required for those who meet the following conditions. This procedure is necessary to continue receiving Third Child Addition payment. A notification has been sent to you, please check it out.

Who needs to go through a procedure: those who have been receiving Child Allowance and have three or more children of age 0 to 22, and among them there's a child born between April 2nd, 2006 and April 1st, 2007.

Required document: *Kango Soto Seikeihi no Futan nitsuiteno Kakuninsho*

(Confirmation of Custody and Living Expenses)

Due date for the document: Tuesday, April 15th. (The document must arrive on or before the date.)

*Upon submission of your completed document by the above stated date, your Third Child Addition will be approved from April, 2025. On the contrary, if the submission is later than the due date, your Third Child Addition will be approved from the month after the submission month.

In order for children in the 6th grade of elementary school to continue to receive multiple additions, it is necessary to submit a document for children who will be in the first year of University.

*If your child graduate from high school or junior collage, etc., if it is certified that the recipient bears most of the living expenses of the target child even after graduation, the third child addition payment will be applied.
