- **Municipal & Prefectural Tax/Forest Environment Tax** 2nd Installment
- **National Health Insurance Tax** 2nd Installment
- **Medical Insurance Tax for the Elderly** 2nd Installment
- **Long Term Care Insurance Tax** 2nd Installment
- **Sewerage beneficiary Burden fee** 2nd Installment

*Deadline is Mon. September 1st. (Same date with direct debit)

*Direct debit is convenient for tax payment. If you want to switch to direct debit, please take the necessary procedures at least one month before the deadline.

<Consultation counter for tax payment on August (SUNDAY)>

Shortfall amount Benefit

The actual income tax and fixed tax reduction figures for 2024 have been finalized, and those who were short of the initial adjustment benefit will be proved with the shortfall. Premium Gift Coupon for Yuki City

Premium Gift Coupon (*Premium-tsuki-shohinken*) can be used at designated stores inside Yuki city.
