### Final Tax Return briefing session by Smartphone

We will be holding a “Smartphone Tax Filing Information Session” in collaboration with Shimodate Tax Office for those who are trying to file their tax returns from their smartphone.

**Date and Time:** Thursday, January 29th.

[1st session: 10:00 a.m.—12:00 p.m.]

[2nd session: 1:30 p.m.—3:30 p.m.]

**Location:** City Hall 4th Floor, Conference Rooms 2 and 3.

**Target:** those who will file income tax return for the year 2025 (Reiwa 7th year).

\*Except tax return subject to income from land/building transfers and Quasi-Final Return.

**Capacity:** 30 applicants are accepted in each session (first come, first served)

#### Things to bring:

- Smartphone (limited to compatible models for *My Number Card* reader)
- *My Number Card*
- Passwords of *My Number Card*      1) four-digit number      2) alphanumeric digits of 6 to 16
- Documents required for Final Tax Return.

### Things to bring:

- My Number Card, or other type of ID and My Number notification, etc.
- Documents that certify your User Identification Number.  
(Those who already got their number for Final Tax Return.)
- Documents that certify your previous year's income.  
(withholding tax certificate, Statement of earnings and expenses, etc.)
- Documents that certify exemption.  
(social insurance premiums, social insurance premiums, medical expense statement, etc.)
- Bank account information (Those who receive a tax refund.)

## Declaration of depreciable assets

Individuals and corporations who own the following depreciable assets within the city are required to report the assets every year. Please report the status of your assets as of January 1st, 2026 to the city taxation division.

**Subject:** structures, machinery, equipment, parts, etc. used for the target business (factories, offices, stores, agriculture, real estate, etc.)

**Due Date for declaration:** Friday, January 30th.

## Medical Expense Notification can be used to deduct medical expense on your Tax Return

For the medical expense deduction, a medical expense notice may be attached instead of a receipt of medical expense. Notification for Nov. and Dec. medical treatment will not be available in time for the tax filing period, so please attach a statement of medical expense deduction prepared based on receipts.

## Reporting damages caused by third-party actions under the Medical Care System for the Elderly

If you use your *My Number Insurance Card*, etc. to receive medical treatment for an injury or illness caused by a third party (other than yourself), such as a traffic accident (including when you are a passenger in a car) or being bitten by someone else's pet, the insured person is required to submit a "Report of damage caused by a third party's actions."

## Be Careful for Water Pipe Freezing and Kerosene Leaks!

Water may not come out or the pipes may burst and leak due to freezing. Please protect water pipes and meter (wrap with heat insulation materials, blanket, etc.). \*Don't use boiled water to defrost. It may break. In case of emergency, please contact the city designated construction company (\*Repair cost will be charged to individuals.) Also, prevent the kerosene spill on water pipes. Kerosene can penetrate the pipes and water will start smelling oily.
