1st period and Full period

Use direct debit to make your payment easier. No need to go over to banks, and you'll never worry about forgetting payments!

\*Please complete the procedure at the bank counter one month before the payment date.

## A Real Estate Tax

Real estate acquisition tax is levied when land or houses are purchased, selling, gifting, exchanging or when you build a new house.

\*Tax amount: the tax base amount multiplied by the following.

- 3% for acquiring land or housing
- 4% for acquiring non-residential house

\*If you acquired a house or residential land, your tax amount may be reduced.

- Those who with 32 or fewer items: Light blue envelope
- Those who with 33 or more items: Brown envelope \* Light blue envelope is enclosed inside.

The validity period of your previous health insurance card expired on December 1st, 2025.

When visiting a medical institution, please place your My Number Health Insurance Card on the card reader at the reception desk. At medical institutions without a card reader, please show your My Number Health Insurance Card and your eligibility information notice at the reception desk.

If you do not have a My Number Health Insurance Card, you will be issued a certificate of eligibility. Please show it at the reception counter.

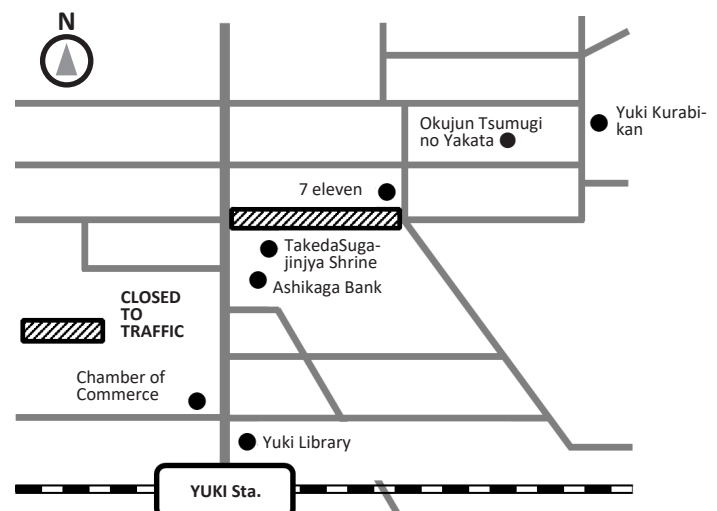
